**ORDER APPROVING
ADMINISTRATION AND
DISTRIBUTION PLAN**

Judge: Hon. Consuelo B. Marshall

On March 4, 2026, Plaintiff Barak Golan filed a Proposed Administration and Distribution Plan (Dkt. No. 225). Having considered the proposed Plan, it is hereby **ORDERED** as follows:

- EAG Gulf Coast, LLC (“EAG”) shall calculate each Class Member’s share of the actual damages awarded by the Court based on the transaction data produced by Defendant.

- 1 • The statutory damages awarded by the Court shall be divided evenly
- 2 among the Class on a per-person basis.
- 3 • Defendants shall provide the transaction data to EAG within ten (10)
- 4 days of the entry of this Order.
- 5 • Within fourteen (14) days of EAG’s receipt of the judgment funds, EAG
- 6 shall disburse the funds to Class Members by check, mailed to Class
- 7 Members’ last known addresses. EAG shall send a letter to each Class
- 8 Member accompanying their checks that is substantially in the form of
- 9 Exhibit B to the Proposed Administration and Distribution Plan.
- 10 • Any undelivered checks will be remailed, and EAG will utilize a skip
- 11 trace process to find new addresses for Class Members whose checks are
- 12 returned.
- 13 • A reminder notice be emailed to Class Members for whom an email exists
- 14 thirty (30) days after checks are mailed to Class Members.
- 15 • Checks shall remain valid for one hundred and eighty (180) days.
- 16 • Any residual funds will be paid to National Consumer Law Center as a *cy*
- 17 *pres* recipient.
- 18 • EAG’s notice plan filed as Exhibit C to the Proposed Administration and
- 19 Distribution Plan is approved, and notice of the judgment shall be given
- 20 to Class Members before funds are disbursed.
